IMPORTANT: Non-tax filers **MUST** provide documentation from the IRS or other relevant tax authority dated on or after October 1, 2024, that indicates a 2023 IRS income tax return was not filed with the IRS or other relevant tax authority, or a signed statement certifying that the individual attempted to obtain confirmation of non-filing from the IRS or other relevant tax authority and was unable to obtain the required documentation. See page 2 for how to obtain an IRS Verification of Non-Filing Letter. **If you are considered a "Dependent Student" and were required to include your parent's 2023 information on your FAFSA application, you are NOT required to obtain an IRS Verification of Non-filing letter.**

Options for obtaining an IRS Verification of Non-Filing Letter

All non-tax filers are required to provide an IRS Verification of Non-Filing Letter dated on or after October 1, 2024, that indicates that a 2023 IRS income tax return was not filed with the IRS.

- Online Request - Go to www.irs.gov/transcript, Click **Get Tax Record**
- **“Get Transcript Online.”** Make sure to request a 2023 Verification of Non-Filing Letter. **Note:** If at any point you cannot validate your identity using the “Get Transcript Online” option, you may use the **“Get Transcript by Mail”** option. Takes about 5 – 10business days.
- Paper Request Form - [IRS Form 4506-T](#) – follow form instructions.
